It is proposed by the Principal Cum Secretary . that (1) Ms.Soumya Sofalika Rout.Date of appointment 1.11.2021 as Lecturer in Botany (2) Ms Muskan Sahoo, date of joining 01.11.2021 as Lecturer in Zoology (3) Sri Subhashree P.Sahoo date of joining 22.11.2021 as Demonstrator in Chemistry and (4)Smt.Kalyani Sahoo date of joining 07.12.2021 as Demonstrator in Botany and all are dis-engagement on 30.4.2022A.N.. Now for their sincerity , punctuality and good performance be regularized from 01.07.2022 F.N. and fresh new appointment be issued.(5) Mrs. Nupur Agrawal, working as contractual appointment from 16.07.2018 with single handed as 02 no of sanctioned post retired from their service and till date the said two post is vacant . Hence Mrs.Nupur Agrawal be regularized under Management payment.

Items No.2: Proposed that, Walk-in-interview was conducted for the contractual appointment for the post of lecturers in Odiya on 27.10.2021 and 10 nos of candidates attended the interview. Mrs Shreemamayee Behera was stood in 1st. position and appointed as lecturer in Odiya from 1.11.2021 to 30.4.2022 for the session 2021-22. But due to poor performance of Smt Behera, the members of the Selection Committee of the college decided not to re-engage her for the session 2022-23.All members of the committee are decide to make a selection among the last panel list and in-spot, phone call made to panel No.1,2,3,4 & 5 . But panel No.2,3,4 denied to join for their personal reason and Panel No.5, namely Mrs Suneli Sharma give her consent to join in the post. Hence, the members of the committee decided to issue an appointment order on contractual basis for one year for the session 2022-23 at the earliest possible for the greater interest of the college as well as the students.
