Sub: Constitution of Governing Body of Aided Degree Colleges-Nomination of President
Regarding

Madam / Sir,

As you are aware, the Odisha Education (Establishment, Recognition and Management of Private Colleges) Rules-1991 has been amended by Government in Higher Education Department Notification No.28214/HE dt.01.09.2020. As per the amended Rules, the State Government have to nominate one person as President for constitution of Governing Body of Non-Government Aided College either suo motu or out of the three persons recommended by the Collector of the district concerned.

As per the Rules, persons, fulfilling the following eligibility criteria can be nominated as President of Governing Bodies of Aided Colleges.

- He/ She must be a graduate from a recognized University
- He/ She must be an eminent academician/ educationist/ retired Government Officer of the State Government or Central Government
- His/ Her age must be between 45 and 67 years

After nomination of the President by the Government, nomination of other members and constitution of Governing Body shall be taken up by the nominated President and Principal-cum-Secretary of the Governing Body, under intimation to the concerned Regional Director of Education.

It may be appreciated that the Odisha Education (Establishment, Recognition and Management of Private Colleges) Rules-1991 has been amended with the purpose of making the Governing Bodies of the colleges more professional by way of induction of eminent academicians or educationists or retired Government officers having vast administrative experience. Therefore, it is imperative that Collectors should be personally satisfied regarding the credentials of the persons before recommending their names for President of Governing Bodies.

Further, it has come to the notice of the Government that till date Governing Bodies of many Non-Government Aided Colleges have not been re-constituted as per the Amendment Rules, 2020. You are, therefore, requested to kindly personally monitor this matter and complete the process of recommendation of the names for President of the Governing Bodies of the Colleges in your district by 31st May 2022.


